#### **Are you or anyone you know needing assistance?**

Currently there are additional funds at the Community Action Center through NOVEMBER 30, for anyone needing assistance paying rent or utilities, etc. with NO income qualifications. If you know of anyone who is struggling, please encourage them to reach out to one or more of these organizations for help.

Additional funding has been made available to COAST. If rides are needed to see doctors, get groceries, pick up prescriptions, etc. help is available. Just contact COAST to schedule a ride. More funding has also been made available to Palouse River Counseling through November 30 if people need mental health assistance due to the pandemic and cannot afford to pay - it will be covered, if they inquire about assistance paying.

Last but not least more funds have been disbursed to all local and regional food banks. PLEASE ENCOURAGE ANYONE IN YOUR TOWN THAT IS FOOD INSECURE TO CONTACT THE LOCAL FOOD PANTRY OR THE PANTRY IN COLFAX FOR ASSISTANCE

## Attention Utility Customers

Soon freezing temperatures and snow will arrive making it impossible to read all of the water meters. This year we will not be estimating the reads each month. We will utilize instead a feature in our billing program that will calculate your usage over the months not read. Processing the bills and reads in this manner means that if you are over one month and under in another it will net out as we are looking at the number of months as a whole. For the months not read you will receive a bill for only the Water Service fees with the first month read including any excess usage you may have.
